
FREQUENCY CHARACTERISTICS

RETURN LOSS



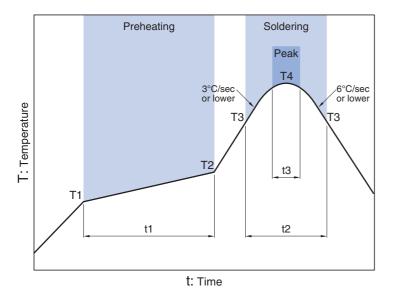
