## **Maximum Peak Pulse Power Rating**




## **Peak Pulse Power and Current Derating**







# **Steady State Power Dissipation Derating**





## **Maximum Non-Repetitive Forward Surge Current**







# **Typical Junction Capacitance**














components. We recommend a manual inspection after potting to avoid these effects.


## **Storage Conditions**
